Dear Preschool parent/guardian,

We are excited that you have selected the St. Vrain Valley School District Preschool Program to meet the social and academic needs for your preschooler for the **2017-18** school year. Our preschool program is delighted to offer three main enrollment opportunities; Colorado Preschool Program, Tuition, and Scholarship. Any preschooler needing special education services must go through the evaluation process for determining eligibility and program placement. For additional information regarding Child Find, please contact them at the number provided below. Please read the detailed information regarding each of the preschool program opportunities. For all three program options, you must complete the attached application. Please be advised: All preschool children must be toilet trained with the exception of students with an IEP prior to starting in a classroom. Classroom Sections at each school are based on enrollment and subject to change. **Once your child has been accepted in a program, you will be asked to complete a registration packet at the school.**

Colorado Preschool Program:

CPP is a state-funded, free program for eligible children identified with certain qualifiers. Children qualifying for CPP are required to attend four half days per week. All CPP preschool students must be four years of age on or before October 1st. To apply, please complete:

- Tuition Assistance Application
- Return or mail in the above forms to the school or the Early Childhood Office for review.
- Contact the Early Childhood Office to schedule a screening appointment for your child (303-702-7815).

Monthly Tuition: Tuition-based preschool opportunities are offered to include two, three, or four day options for both three and four year old students depending on the preschool program. All preschool classrooms are half day mornings or afternoons. To apply, please complete the following:

 - Return or mail in the application to your elementary school for review**
- *An Application must be submitted to each school you are applying to**

Monthly program fees are based on half day sessions: T/Th \$185, M/W/F \$235, M-Th \$290 if applicable. There is also a \$65 registration fee once accepted in a preschool program.

Scholarship:

St. Vrain Valley School District offers scholarships for three year olds (three by Oct. 1st) as funding is available for **eligible** families. To apply, please complete the following:
