DISCUSSION ITEMS (9.0)

Firestone Urban Renewal Authorities (9.1)

An Executive Session was held at 5:30 pm before tonight's Special Board meeting to discuss negotiations regarding Intergovernmental Agreements (IGA) concerning the proposed Urban Renewal Authorities in the Town of Firestone.

Wes LaVanchy, Firestone Town Manager, and Bruce Nickerson, Firestone Town Planner, presented the Town of Firestone proposal using an IGA model that the Loveland Urban Renewal Authority and the Thompson School District used.

Erie Urban Renewal Authorities (9.2)

An Executive Session was held at 5:30 pm before tonight's Special Board meeting to discuss negotiations regarding Intergovernmental Agreements (IGA) concerning the proposed Urban Renewal Authorities in the Town of Erie.

AJ Krieger, Town Administrator, presented the Town of Erie proposal. On the advice of the Board, the Town of Erie will draft a proposed agreement outline for consideration as soon as possible.

Review Mill Levy Override Ballot Question (9.3)

The Board of Education and the administrative team discussed language that could be used in the ballot if the District should decide to ask for a mill levy override for the November 6, 2012 Coordinated Election.

The Board collectively agreed that administration should ask voters to approve a \$14.8 million mill levy override. Board members that were present indicated they would prefer to provide tonight's absent members, Rod Schmidt and Mike Schiers, an opportunity to indicate their thoughts about the dollar amount to ask voters at the August 8th Board meeting.

A vote on the final ballot language will take place at the August 8, 2012 Board Regular meeting.

Senior Tax Work-Off Program (9.4)

The Board expressed concerns about the impact of a potential mill levy increase on senior citizens and disabled homeowners on a fixed income. Staff has done research and provided information about the possibility of allowing seniors and disabled citizens to work in the schools and earn money towards their property taxes.

The Board was collectively in favor of the Senior Tax Work-Off Program. The Board will vote on implementing the program at its August 8, 2012 Regular Meeting.

It was recommended by Terry Schueler, Chief Financial Officer, that this program be implemented if a mill levy override passes this November.

Review 2012-2013 Board of Education Working Calendar (9.5)

Board members were encouraged to review the 2012-2013 Board Working Calendar and make any additions and deletions necessary.
