Approval of Resolution Calling an Election and Declaring a Mill Levy Override Question (8.4) (Action Item 8.4 was discussed before Action Item 8.3 this evening.)

Bob Smith moved that the Board of Education adopt a resolution for a mill levy override for the November 6, 2012 election. Joie Siegrist seconded.

As the State of Colorado budget crisis has resulted in reduced state funding for K-12 education, the St. Vrain Valley School District's per pupil funding has been reduced significantly from \$7,085 in August 2009 to \$6,332 in August of 2012. This reduction of \$753 per pupil in the last four years has caused the District to reduce staff, delay textbook replacement cycles, spend one-time money reserves, and has diminished our ability to recruit and retain staff.

During the same four years, the 2008 mill levy override dollars has enabled the District to make up for the impact of lost funding to some extent. However, due to a significant increase in student population and continued loss of revenue, it has become necessary for the question of a mill levy override to be placed on the local ballot for the November 6, 2012 election.

Livvy Bahr, 6460 Coralberry Court, Niwot-5th grader in the gifted and talented program at Niwot Elementary supporting the mill levy override.

Paula Peairs, 2017 Sundance Drive, Longmont, 80504-Community Task Force member supporting mill levy override on the ballot on November.

Carolyn Storz, 866 Yellowstone Road, Longmont, 80503-Community Task Force member. Supports the inclusion of a mill levy override on the ballot in November. She feels it is the responsibility of the community to provide an excellent education for our students. Encouraged the Board to let the community decide on a vote of support for the District.

Stacey Bahr, 6460 Coralberry Court, Niwot-Supporting Grassroots St. Vrain and their work in favor of the mill levy override.

Laura McDonald, 8824 Walker Road, Longmont, 80503-Speaking on behalf of Grassroots St. Vrain. Wants the community to sustain the progress the District has made in the last four years by supporting a mill levy override for a quality education for our children. Grassroots St. Vrain strives to let the community have the option to vote for a mill levy override.

Ken Schuetz, 2206 Eagle View Circle, Longmont, 80504-Asked to lead the campaign for the mill levy override. Yes on 3A Committee has been organized and ready to move forward, pending approval by the Board of Education.

Trip Merklein, 2007 Red Cloud Road, Longmont, President of St. Vrain Valley Education Association-Supports the mill levy override and the work of Grassroots St. Vrain. Felt it is critical that this ballot measure be offered to the St. Vrain community.

LaVern Johnson, Box 9, Lyons-Supports the mill levy override, and encouraged the community to pass a referendum in November. She is a member of the Lyons Town Board of Trustees.

Board members each had the opportunity to voice their opinions about the amount to ask the voters for in the mill levy override. Each member varied on that total but concluded that the \$14.8 million dollar figure would be best for the District at this time.

Board members praised the Grassroots St. Vrain group for all that they have been able to accomplish for the District and the community, and agreed with Grassroots St. Vrain that the Board should put the measure on the 2012 ballot and let the community have the opportunity to decide.

Board President John Creighton read the Resolution to the audience.

Approval of Resolution to Adopt a Position of Advocacy in Support of the Ballot Issue-Matters of Public Concern (8.3)

Rod Schmidt moved that the Board of Education approve a Resolution adopting a position of advocacy in support of a ballot issue, declaring the issue to be a matter of public concern. Debbie Lammers seconded.

As per Section 1-45-117, C.R.S., of the Fair Campaign Practices Act, the Board is adopting a position of advocacy in support of a mill levy override ballot issue. The Board unanimously and enthusiastically supports the mill levy override ballot issue and urges the voters of the District to vote "yes" on Ballot Issue 3A at the November 6, 2012 election.

Board member Debbie Lammers read the Resolution to the audience.

Approval of Resolution to Implement Senior Tax Work-Off Program (8.5)

Bob Smith moved that the Board of Education adopt a Resolution in support of implementing a Senior Tax Work-Off Program should the 2012 mill levy override pass. Joie Siegrist seconded.

A Resolution to implement the Senior Tax Work-Off Program was discussed at the Board Meeting on August 1, 2012. This Resolution establishes a property tax work-off program for senior taxpayers and those with disabilities to perform services to the District to reduce their property tax payments in the event of the 2012 mill levy override passage. This Resolution is in line with the discussion of the program, is recommended by the administration, and has been reviewed by District legal counsel.

One hundred applicants will be allowed from each county - Boulder and Weld. Dr. Don Haddad added that this program will mitigate both mill levy overrides (2008 and 2012). Should the mill levy pass in November, applicants will be able to apply before the winter break.
