- Dr. Haddad thanked Board members for all the time they spend with the students and in the schools, and invited them to the Leadership meeting being held on Thursday, May 2, from 8:30 to 11:00 am at Xilinx.
- Announced that Encana Oil & Gas Company has given a \$34,000 donation to Coal Ridge Middle School for a mobile computer lab.
- Reported that SB 191 is moving along nicely-appreciate the work of David Burnison, Trip Merklein, Tori Teague, Mark Mills and Amy Weed for their help on this project.
- The last late start day of the year will be used to make sure each staff member understands the changes that SB 191 will bring for the new year.
