SUBJECT: Approval of Motion to Approve a Resolution Authorizing Designated

Election Official to Cancel Election Due to Lack of Opposing Candidates

## **RECOMMENDATION**

That the Board of Education approve a resolution authorizing the Designated Election Official to cancel the November 5, 2013 Coordinated Election due to a lack of opposing candidates.

## BACKGROUND

Colorado Revised Statute §1-5-208(1.5) provides that in the event that at the close of business on the sixty-third day before the election to be conducted on November 5, 2013, there were not more candidates for director to the Board of Education than offices to be filled, including candidates who were allowed to file affidavits of intent to be write-in candidates, the Board may authorize the Designated Election Official to cancel the election by resolution and declare the candidates elected, as of November 5, 2013.

Terry Schueler, Designated Election Official, for the District submits the attached resolution for cancellation of the election, naming Joie Siegrist for Director District A for a two-year term from 2013-2015; Debbie Lammers for Director District B for a four-year term from 2013-2017; John Ahrens for Director District D for a four-year term from 2013-2017; and Paula Peairs for Director District F for a four-year term from 2013-2017.

# A RESOLUTION OF THE BOARD OF EDUCATION OF THE ST. VRAIN VALLEY SCHOOL DISTRICT RE-1J AUTHORIZING THE DESIGNATED ELECTION OFFICIAL TO CANCEL THE ELECTION AND DECLARE THE CANDIDATES ELECTED

**WHEREAS**, if the Designated Election Official of the St. Vrain Valley School District RE-1J determines that, at the close of business on the sixty-third day before the election to be conducted on November 5, 2013, there will not be more candidates for director than offices to be filled, including candidates who were allowed to file affidavits of intent to be write-in candidates; and

**WHEREAS**, the Board has not referred any ballot issue or ballot question to the District's electorate at the November 5, 2013 election; and

**WHEREAS**, § 1-5-208(1.5) C.R.S., provides that in such event, if the only matter before the District's electors is the election of directors to the Board of Education, the Board may authorize the Designated Election Official to cancel the election and declare the candidates elected;

# NOW THEREFORE BE IT RESOLVED BY THE BOARD OF EDUCATION OF THE ST. VRAIN VALLEY SCHOOL DISTRICT RE-1J THAT:

- 1. The Designated Election Official may cancel the regular election to be conducted on November 5, 2013 if there is no contest for any office, including candidates filing affidavits of intent to be a write-in.
- 2. Upon such cancellation, the Board declares the following candidates to be deemed elected for the terms indicated, effective as of November 5, 2013:
