# First Quarter Gifts to Schools, 2013-2014 School Year (6.1)

Terry Schueler provided the Board of Education with a list of public gifts given to the St. Vrain Valley School District for the first quarter of the 2013-2014 school year totaling \$81,695.08. At this time last year, \$118,325.13 had been received.

### 2012-2013 Scholarship Recipients (6.2)

Terry Schueler reported to the Board of Education that St. Vrain Valley students were awarded a total of \$375,169 in local scholarships and awards, and were offered a total of \$12,308,293 in scholarships and awards from colleges and universities across the country. The Board and administration thanked Linda Lohmann for tracking that scholarship information.

# Adoption of Resolution Proclaiming National School Lunch Program Week, October 14-18, 2013 (8.1)

Debbie Lammers moved that the Board of Education adopt a Resolution proclaiming October 14 - 18, 2013 as National School Lunch Program Week. Bob Smith seconded.

Each year, there are more than 500 billion school lunches served nationwide via the National School Lunch Program. In recognition of the positive changes St. Vrain Valley Schools has made to its own school lunch program, we will celebrate National School Lunch Week (NSLW) from October 14-18. The 2013 theme, "School Lunch - What's Cooking?" will include menus that promote the benefits of healthy school lunches.

# Approval of Accreditation Recommendations for District Schools (8.2)

Dori Van Lone moved that the Board of Education approve the accreditation recommendations for schools within the St. Vrain Valley School District, as presented. Rod Schmidt seconded.

The District Accountability/Accreditation Committee is made up of parents and community members from director districts, an elementary principal, a secondary principal, a teacher, and a charter school representative. Tori Teague also works with the Committee as a liaison from the District. The Committee met on September 10, 2013 to review the performance of the District's schools. As a result of the meeting, the Committee recommends accreditation status for schools as presented to the Board.

Proclaiming this date as Classified School Employees Week helps to promote public awareness of the importance of classified employees in the public school system. As much as any other group of employees, classified school employees are a valued and integral part of the school system and their work is vital to the success of children.

# <u>Approval of Waiver from Liability Insurance Requirement for the Frederick High</u> School Education Foundation (8.4)

Joie Siegrist moved that the Board of Education allow an exception to the Organizational Options for Parent Organizations Policy KBE-R, and thereby approve a waiver for the general liability insurance requirement for the Frederick High School Education Foundation. Dori Van Lone seconded.

Board Policy KBE, Relations with Parent Organizations, states, "District insurance does not cover parent organizations organized as non-profit corporations. Furthermore, the District is not liable or responsible for loss of their property or money, or the decisions made by the non-profit corporation, its board, or its officers. The non-profit corporation is encouraged to investigate and purchase appropriate officer's liability insurance,

property insurance, and crime insurance (fidelity bond), in addition to the general liability insurance required by the District."

The Frederick High School Education Foundation appealed for a waiver from Policy KBE-R due to the fact that they do not use District facilities except for their meetings. These waivers are consistent with past practices and have been reviewed by the District's legal counsel. The attorney for the District has reviewed and agreed with the waiver as presented.

# Adoption of Resolution Approving St. Vrain Community Montessori School 3-Year Charter Operating Contract (8.6)

Bob Smith moved that the Board of Education adopt a Resolution approving renewal of the operating contract for the St. Vrain Community Montessori School for a term of three years, extending through the 2015-2016 school year. Joie Siegrist seconded.

On January 11, 2012, the Board of Education approved the 10-year charter renewal application of the St. Vrain Community Montessori School, and on August 14, 2013 the Board re-approved the renewal by Resolution in order to meet state statute requirements.

The Colorado Department of Education has now requested that the Board also rule by Resolution on the 3-year operating contract that the Board previously approved on June 26, 2013.

# Adoption of Resolution Approving Grade Extension Application for St. Vrain Community Montessori School (8.7)

Rod Schmidt moved that the Board of Education adopt a Resolution to authorize St. Vrain Community Montessori School (SVCMS) to serve grades PK-8 in accordance with the terms of the current Charter Renewal Term of ten years, which presently extends through June 2022. Dori Van Lone seconded.

On July 30, 2013, the SVCMS submitted a grade extension application to the District in order to become a PK-8 school. SVCMS intends to open the middle school in the fall of 2014 in order to serve 7th grade students, and 8th grade will be added in the fall of 2015.

Katie Torres, Head Master for St. Vrain Community Montessori School, answered questions from the Board members. Congratulations were given to her from the Board on their accountability and partnership.

# <u>First Reading, Introduction, Board Regulation IKF-R – Graduation Requirements-</u> Physical Education Waiver (9.1)

Connie Syferd reported that revisions to this policy are necessary due to alignment with current practice, procedure, and applicable statutes and have been reviewed by District administration.

Board members suggested changes to the policy to have a more clear definition of a full-time student and wording to include concurrent enrollment students. The Board also wanted assurances that fair practices would be adhered to for consistency across the District when waiving PE credit. They also asked that Connie Syferd and Rob Berry widely distribute this policy to 8<sup>th</sup> graders as a high school planning tool.

This policy will go for its second reading at the November 13, 2013 Regular Meeting.

Board members thanked Rob Berry for the monumental task of rescheduling all the athletics during the flooding. Rob reported that all District Athletic Directors were very instrumental in assisting in that task.
