REPORTS (6.0)

Longmont High School Student Advisory Council Feeder Report (6.1)

Mark Mills introduced Northridge Elementary Principal Lorynda Sampson who announced that Oskar Blues and Whole Foods teamed up to present Northridge 1st and 2nd grade students 113 brand new bikes and helmets. Many community members helped put the bikes together and custom fit them to each student. Lorynda reminded everyone how important partnerships between schools and businesses are, and that this type of support is what Christmas is all about. Board members recognized Lorynda for the tremendous leadership that she provides at Northridge.

Mark Mills introduced Longmont High School Principal Rick Olsen who then introduced Longmont Student Advisory Council students Delaney Christopher, Lane Chesnut, Evangeline D'Epagnier, and Adam Pena (Board of Education Liaison). The students showcased special programs about each of the Longmont feeder system schools. Rick thanked the students for their outstanding report, and students told the Board of their future plans and introduced parents that were present at the Board Meeting. Other Longmont feeder system principals in attendance: Ann Reed, Principal of Longs Peak Middle School; Jim Hecocks, Principal of Central Elementary; Renee Collier, Principal of Hygiene Elementary; Jennifer Ryan, Principal of Mountain View Elementary; Lorynda Sampson, Principal of Northridge Elementary; and John Wahler, Principal of Sanborn Elementary.

October Enrollment Report 2016/2017 and Open Enrollment for 2017/2018 (6.2)

Scott Toillion provided the Board of Education with a report regarding student enrollment for the 2016-2017 school year and Open Enrollment for the 2017-18 school year. Three things that stood out this year for Scott were that there was a considerably smaller number of kindergartners, fewer open enrollments from out-of-district, and lower growth in charter schools for a second year in a row.

The District continues to experience steady growth in enrollment. Over the last ten years, the District has added an average of 824 students per year. Last year, the District passed Boulder Valley in enrollment to become the 7th largest District in the State. Enrollment now stands at 31,104, up from 30,691 in 2015. This is a growth rate of 1.35% and a gain of 413 students from the 2015 October Count. The overall count including all pre-school students and other District programs has risen to 32,276 students. The greatest gains were in the Erie feeder schools (+221 students), Mead feeder schools (+131), the Frederick feeder schools (+69), and the Longmont feeder schools (+62). All feeders saw growth except for declines in the Niwot feeder and in the charter schools.

The District neighborhood schools/program enrollment came in at a -0.81% error from the anticipated projection (Projected: 28,120 Actual: 27,894). Including the charter school projections, the projection error was -1.00%. (Projected: 30,792 Actual: 30,691). The largest gaps were projected growth of the charter schools, the Niwot feeder, and the Silver Creek feeder. Charter schools provide their estimate of growth to the District, and each of the projections for the six charter schools were not met by actual enrollment.

The 2015/2016 October Report additionally details the changes in enrollment at a school-by-school level, provides information on birth numbers, free/reduced lunch counts, ethnic breakdowns, English language learners, private school and home school enrollment, the impacts of choice, enrollment projections, building permit activity by community and a variety of other indicators.

For the open enrollment period that extends through January 17, 2017, all schools will receive all applications. By February 7, 2017, schools will notify applicants of their approval status. As capacity is added as a result of the successful 2016 bond election, open enrollment will become more available across the District.

Board members expressed their appreciation of Scott and his staff for always providing a very thorough report and for his accurate projections year after year.

1st Quarter Financials, 2016/2017 Fiscal Year (6.3)

Greg Fieth provided the Board of Education with the financial report for the first quarter of Fiscal Year 2017. At the worksession prior to this Board meeting, information related to the financial statements for the quarter ending September 30, 2016 were provided to the Board. These financial reports were reviewed by the Finance and Audit Committee on December 12, 2016.

District-Wide Savings on Procurement Activities FY16 (6.4)

Tim Wellmann provided the Board of Education an annual report regarding the key functions and efficiencies in the Purchasing Department. The Purchasing Department provides buying and contracting services in support of all District schools and departments and coordinates the sale and disposal of District surplus property. He demonstrated the value Purchasing Services provides the District as shown through established key performance measures including procurement cost savings data, vendor participation, solicitation process lead time, procurement card rebate potential, and surplus property sale proceeds and disposal processes.

Board members were impressed with the Purchasing Department's money-saving results for the year.

Purchasing Department Award (6.5)

Greg Fieth announced that the Purchasing Department was awarded the Excellence in Achievement Sterling Agency Certification Award - St. Vrain Valley School District is a 2016 recipient of the Universal Public Procurement Certification Council (UPPCC) Sterling Agency Certification Award.

This award is an advanced level of recognition reserved for those agencies that apply for and achieve UPPCC Agency Certification Award recognition for three consecutive years. The SVVSD professional procurement team achieved fully certified public procurement status in 2014 through 2016.

Through its Agency Certification Award Program, the UPPCC identifies organizations that have earned the distinguished and unique honor of achieving and/or maintaining a high percentage of qualifying staff that are UPPCC Certified. This program was developed to recognize organizations that have made a concerted effort to achieve procurement excellence. The Purchasing Department certified staff consists of Traci Burtnett, CPPO, CPPB, Director; Tim Wellmann, CPPB, Purchasing Manager; Diana Cantu, CPPB, Senior Buyer; and Bill Oliver, CPPB, Senior Buyer.

Brian Lamer explained why the cost went up for the projects in Consent Agenda Items 7.7 and 7.8 and how architects are selected. He stated that new projects are not as complicated because new projects start from scratch. Existing buildings that will have additions have to be thoroughly researched in order to determine the precise placement of additional capacity.

John Ahrens moved to approve Consent Agenda Items 7.7 and 7.8. Amory Siscoe seconded.

ACTION ITEMS (8.0)

Approval of Director District Reapportionment (8.1)

Dr. Richard Martyr moved that the Board of Education approve the proposed director districts in order to equalize the population in compliance with Colorado State Statute 22-31-109 (110). Amory Siscoe seconded.

Scott Toillion reported that Board of Education Directors are elected by the entire School District electorate. However, each director represents a specific area of the District. State statute requires each director district be equal in population, and this reapportionment is required every four years.

Director districts were last drawn in 2012. These districts were drawn using criteria that sought to equalize the population and align with streets, township boundaries, and/or geographic features. Maps were provided showing the current and revised districts, as well as a listing of District facilities within each proposed director district.

The District's Geographic Information System (GIS) was utilized with data obtained from county, state, and municipal governments, as well as from the U.S. Census Bureau. Care was taken to make the process as consistent as possible across the whole District. The average population in each district in 2012 was 22,484. That average has increased to 23,445. Overall, the District's population has increased from 157,389 in 2012 to an estimated population of 164,118 today.

Population estimates are structured by calculating Population Estimate = (dwelling units x Occupancy rate) x Average Household Size + Group homes.

While growth was spread across the entire school district, director districts D & G saw the highest gains. In order to equalize the population in each of the districts, the gains in D & G were redistributed across A, B, C & F.

District E's estimated population of 23,278 is very close to the average. As a result, only a small change is proposed. The proposed change removes a small area from E to allow District B to align with the Burlington Elementary attendance area and does not affect any existing residences.

The following changes are proposed to equalize director district populations:

- 1. The proposed changes are incremental in nature.
- 2. District A is realigned to include a small portion of District C in northwest Longmont. The boundaries of this change are Hover Road on the west to Spencer Street on the east, and 21st Avenue on the north, south to 17th Avenue.
- 3. District B follows the Burlington Elementary attendance area south of Ken Pratt Boulevard in Longmont.
- 4. District C aligns with the Alpine Elementary boundary north of Ute Creek Golf Course to Highway 66.
- 5. District F follows Colorado Boulevard South, then bisects the Booth Farms neighborhood east to Birch Street, south along Birch Street to WCR 20 1/2 (extended) including the Stoneridge subdivision and Idaho Creek subdivision west of I-25.
- 6. As mentioned above, District E is realigned to exclude the commercial and public areas south of Ken Pratt Boulevard.

These changes do not affect the schools/facilities represented by each director. Each director will continue to represent the same schools as prior to the realignment.

Dr. Richard Martyr moved that the Board of Education certify the 2016 mill levies to the Counties of Boulder, Weld, Larimer and the City and County of Broomfield as presented, and further authorize the Board President to sign the certification documents. Paula Peairs seconded.

Tony Whiteley reported that Colorado Statute requires school districts to annually certify mill levies for the presented funds to the respective county commissioners by December 15 of each year. Tony discussed in detail each of the counties' mill levies and answered questions from Board members.
