Responsible Use of the Internet and Electronic Communications

ACTION ITEMS (8.0)

Adoption of Capital Reserve Budget for 2017/18 (8.1)

Joie Siegrist moved that the Board of Education adopt the Fiscal Year 2018 Capital Reserve allocations of \$5,800,000 as presented and authorize Brian Lamer, Assistant Superintendent of Operations, to sign appropriate documents related to the disbursement of funds. Amory Siscoe seconded.

Brian Lamer reported that the Capital Reserve allocations presented follow the Capital Reserve Handbook that outlines the process and procedure for Capital Reserve fund allocations.

The following identified recommendations presently proposed for the budget expenditures for 2018 are: Arts/Athletics-\$129,000; Maintenance/Grounds-\$2,261,500; Support Services-\$1,714,500; Custodial/FFE-\$398,000; Transportation-\$1,267,000; and Environmental-\$30,000. However, as need, scope and bidding conditions change, these numbers could vary slightly.

Dr. Haddad added that student safety and instruction is always taken into account in replacing furniture and fixtures, and the capital reserve resources cover one years' worth of projects.

Approval of Medicaid Contract (8.2)

Paula Peairs moved that the Board of Education approve a contract with the Department of Health Care Policy and Financing with the State of Colorado, and further authorize Greg Fieth, Chief Financial Officer, to sign all necessary documents. Dr. Richard Martyr seconded.

Greg Fieth reported that this contract allows the District to be compensated for providing health services to students who are receiving Medicaid, and for providing Medicaid Administrative Activities. Within the capacity of the specific School Health Services (SHS) Program, the District can receive reimbursement in the form of federal funds only from the Department for School Health Services that are medically necessary and provided to Medicaid eligible students as prescribed in the student's Individual Education Program (IEP) or the Individualized Family Service Plan (IFSP). School Health Services may include direct medical services, including rehabilitative therapies, Early and Periodic Screening, Diagnostic and Treatment (EPSDT) services, targeted case management (TCM) and specialized non-emergency transportation services. The District may also receive federal funding for performing administrative activities which

include service coordination, outreach, referral, enrollment and administrative functions that support the Medicaid program.

The District has provided these services and has been compensated by the State of Colorado without a formal contract for many years. This year, the State of Colorado is formalizing the contract. The District's legal counsel has also reviewed the document.

Approval of Request to Grant Exception to Staff Ethics/Conflict of Interest-Board Policy GBEA (8.3)

Dr. Richard Martyr moved that the Board of Education allow an exception to the current Staff Ethics/Conflict of Interest, Board Policy GBEA. This exception would enable Heather Rogers, a District employee, to market her face painting services to the Community Schools Program. Joie Siegrist seconded.

Greg Fieth reported that Board Policy GBEA, Staff Ethics/Conflict of Interest, states, "No school district employee or firm owned by a school district employee shall be allowed to sell to the district or its schools or staff goods or services of any kind without express prior written consent of the Board of Education."

Heather Rogers is employed by the District as a Custodial Supervisor. She also runs a face painting business, "See Life as a Muse". Her services would be offered through Community Schools as a vendor.

Since Ms. Rogers is an employee and she owns her business, she is requesting a waiver from Board Policy GBEA so she can continue to offer these services through Community Schools within the St. Vrain Valley School District. Administration recommends approval of this exception.

Board members and administration discussed ways to streamline the requests to grant exceptions to Board Policy GBEA.

Dr. Diane Lauer and Brandon Shaffer explained to the Board that the new Colorado Student Data and Transparency & Security Act perpetuated the creation of these new Board policies and that administration and District legal counsel had reviewed CASB samples of those policies and revised them for St. Vrain best practices. Brandon assured the Board that these new policies will exceed the requirements of the new Act. Dr. Lauer thanked Brandon Shaffer, Joe McBreen and Patrick Mount for covering that new legislation from the very beginning. Board members and Dr. Lauer feel very fortunate to have Brandon Shaffer on staff for his expertise and coordination with projects such as this.

Board members moved that these new Board policies will enter their second reading, with no changes, at the May 24, 2017 Regular Board Meeting.
