Adoption of Resolution Approving 2017-2018 District Employee Membership in Colorado High School Activities Association (CHSAA) (8.1)

Dr. Richard Martyr moved that the Board of Education adopt a resolution approving 2017-2018 District employee membership in CHSAA. Debbie Lammers seconded.

Rob Berry presented a resolution detailing the District employees and the membership positions they hold in CHSAA. The Board of Education recognizes the services of the individuals listed in the resolution to be within the scope of employment of school district personnel and within the performance of those duties as employees of the school district, as members of the Board of Directors of the CHSAA or as a member of other CHSAA committees, Legislative Council or interscholastic activity league committees under CHSAA. Rob confirmed that the purpose of the resolution and approval by the Board covers these employees for liability purposes.

Board members and Dr. Haddad congratulated Rob on his leadership, an amazing fall athletics/activities season, and his excellent work in hiring great coaches.

Adoption of Resolution Proclaiming Classified School Employees Week, October 16-20, 2017 (8.2)

Ella Padilla reported that proclaiming this date as Classified School Employees Week will help to promote public awareness of the importance of classified employees in the public school system. As much as any other group of employees, classified school employees are a valued and integral part of the school system and their work is vital to the success of children.

Board member Dr. Richard Martyr read the resolution. He commended Brian Lamer and his team for the quality of all District facilities.

Approval of Accreditation Recommendations for District Schools (8.3)

Amory Siscoe moved that the Board of Education approve the accreditation recommendations for schools within the St. Vrain Valley School District. Joie Siegrist seconded.

Tori Teague reported that the District Accountability/Accreditation Committee is made up of parents and community members, an elementary principal, a secondary principal, and a teacher. She works with the Committee as the liaison from the District. The Committee met on September 12, 2017, to review the performance of the District's schools. As a result of the meeting, the Committee recommended the accreditation status for the schools, as presented.

The Committee follows the guidelines of SB 09-163 to recommend accreditation levels for schools and uses Colorado Department of Education's (CDE) School Performance Frameworks to identify accreditation levels of schools. The framework considers the following data areas to determine school accreditation levels; Academic Achievement, Academic Growth, and Postsecondary and Workforce Readiness. Olde Columbine High School and St. Vrain Online Global Academy are CDE approved alternative campuses and use different assessment data for the framework calculations. St. Vrain Online Global Academy was approved this August as an alternative campus, so the District is appealing their original rating to the rating for an alternative campus. The alternative campus rating is what is recommended in this report. Tori described the process the District must go through for their alternative school status.

The Committee recommends District Learning Services' personnel meet with schools that are accredited with an improvement, priority improvement, or turnaround plan. At those meetings, schools are asked to answer questions about their current performance, plans to improve that performance, for any additional data that the school might have collected, and what support needs to be provided by the District. The Committee may also request to meet with schools and/or District Learning Services to discuss school improvement plans.

Approval of Contract-The Wild Plum Center for Young Children and Families (8.4)

Dr. Richard Martyr moved that the Board of Education approve the service agreement between the District and The Wild Plum Center for the 2017-2018 school year. The District pays for these slots through the Colorado Preschool Program grant funds that are provided through the State of Colorado. Debbie Lammers seconded.

Dr. Diane Lauer reported that the District, through its Early Childhood Department and District Advisory Council, enter into this agreement with the Center in order to provide preschool services to eligible 4-year-old children. The District will pay a monthly tuition rate of \$290.00 per each child placed (not to exceed 48 children).

Dr. Lauer reported that there are other service providers besides The Wild Plum, but that the amount attached to the agreements do not warrant approval by the Board. The \$290 monthly tuition provides free entry to preschool for those 48 students, so there is no cost to the families.

Debbie Lammers moved that revisions to Board policies JKA – Use of Physical Intervention and Restraint; and JKA-R – Use of Physical Intervention and Restraint be adopted as presented. Joie Siegrist seconded.

Dr. Diane Lauer reported that the revisions to these Board policies were all mandated by newly enacted laws. Board members chose to approve them after one reading, per Board Policy BG – School Board Policy Process that states "Policy revision shall be accomplished in the same manner as policy adoption, except that revisions mandated by changes in law shall not require a second reading and may be adopted upon majority vote of the Board."

Laura Hess was present to answer questions from the Board. The Board commended her for the work she has done to assure that these Board policies were in compliance with state and federal law.
