Education Foundation for the St. Vrain Valley (EFSVV) Executive Director Josh Atherton was present to introduce Longs Peak Middle School STEM teacher Colin Rickman. Colin was the recipient of the 2018 Eleanor Venture award, and shared a video of his experiences in Cape Town, South Africa. Board members thanked Colin for sharing his experiences.

- Announced the November 8, 2018 Discovery Education presentation at the Innovation Center, and the November 9, 2018 Colorado Technology Association event that will recognize Joe McBreen and his team.
- October Count window ended today, and he looks forward to sharing preliminary results at the October Study Session.
- Visited all schools looking forward to seeing District football teams in playoffs.

- Announced that Northridge Elementary was awarded the Colorado Succeeds \$15,000 prize, presented by Ball Aerospace, for excellence in STEM education.
- Thanked Jackie Kapushion for her leadership in all high profile events happening in the District. Thanked the Board members for attending those events – really appreciates the Board's visibility. Jackie Kapushion thanked Dr. Haddad for choosing the leadership team she works closely with to create those events.

# REPORTS (6.0)

# **Erie High School Student Advisory Council Feeder Report (6.1)**

Bryan Krause introduced Erie High School Principal Matt Buchler who then introduced Erie High School Advisory students Raegyn Patzer, Rylee MacLennan, Cassie Mahakian, Patrick Cummings, and Christian Haakmeester. Erie Advisory member Westley Cody was unable to attend the meeting. Each student serves a two-year term. Their theme this year is "Brilliance across Erie" – highlighting all the STEM programs. The students recognized Grayson Wolff for creating the video they presented. Matt recognized Erie High School for significant gains in their SAT scores, and Black Rock Elementary for their Fourth Grade English Language Arts and Math assessment scores being the highest in the District. The students showed a video of their feeder system, and each shared their plans for the future and introduced their parents. Other administrators who was present from the Erie feeder system were Erie Middle Principal Kim Watry; Erie Elementary Principal Lauren Eker; and Grand View Elementary Principal Kirsten McNeill. Board members commended the students for their presentation, and recognized all the building leaders for attending.

# 1st Quarter Gifts to School, 2018-2019 School Year (6.2)

Greg Fieth provided the Board of Education with a list of public gifts given to the St. Vrain Valley School District for the first quarter of the 2018-2019 school year totaling \$161,436.55. Greg highlighted a few of the donations from corporate partnerships.

# **Bond Sale Update (6.3)**

Greg Fieth updated the Board of Education on the sale of \$60.34 million in bonds, and introduced Todd Snidow, Executive Vice President of George K. Baum.

On November 8, 2016, the electorate of the St. Vrain Valley School District approved the issuance of \$260.34M in bonds for projects cited as critical needs District-wide. At their September 12, 2018 Regular Meeting, the Board approved selling the last \$60.34M to fund the remaining projects.

On September 19, 2018, the District sold the remaining bonds with a five-year bond maturity. The resulting yields ranged from 1.72% to 2.21% which, combined with the rates locked in at the time of the sale of the initial \$200M in December of 2016, provided a net interest cost of 3.57% for the full issue. Shortening the repayment period to only

five years saved local taxpayers over \$12M in interest expense compared to the original 14-year schedule. The final results of the 2016 bond authorization show that the total principal and interest to be repaid is over \$21M less than the voters approved in 2016.

Todd stated that the timing of the sale of the bonds was critical, and that administration should be very proud of the District's upgraded credit rating from AA to AA+. Dr. Haddad thanked Todd for his years of support, and thanked Greg for his leadership. Two Board members and two Finance and Audit Committee members were able to attend the sale of the bonds. Board members thanked Todd for the opportunity to participate.

Board members discussed new Board Policy KBA-E which is very prescriptive regarding roles and responsibilities for staff and parents. Dr. Diane Lauer reported that the wording flows from new Title I legislation and District legal counsel, and the intent is for best practices to be consistent across all District schools.

# **ACTION ITEMS (8.0)**

# Approval of Accreditation Recommendations for District Schools (8.1)

Joie Siegrist moved that the Board of Education approve the accreditation recommendations for schools within the St. Vrain Valley School District, as presented. Karen Ragland seconded.

Tori Teague reported that the District Accountability/Accreditation Committee is made up of parents and community members, an elementary principal, a secondary principal, and a teacher. Tori works with the Committee as the liaison from the District. The Committee met on September 11, 2018 to review the performance of all District schools.

St. Vrain Community Montessori is appealing their Improvement Plan rating to CDE and requesting a rating of Insufficient Data because their rating is based on the performance of 20 students who tested. Their enrollment last year was 270.

Board members praised Tori for the amount of work that goes into compiling these measures of student achievement, and encouraged staff and the public to celebrate the progress we've made while taking great pleasure in this year's outcome. Board members asked Tori to pass on their appreciation to the Accountability/Accreditation Committee for all the work that they do on behalf of the District.

# Adoption of Resolution Approving 2018-2019 District Employee Membership in Colorado High School Activities Association (CHSAA) (8.2)

Paula Peairs moved that the Board of Education adopt a Resolution approving 2018-2019 District employee membership in CHSAA. John Ahrens seconded.

Rob Berry recognized the services of the individuals listed in the Resolution to be within the scope of employment of school district personnel and within the performance of those

duties as employees of the school district, as members of the Board of Directors of the CHSAA or as a member of other CHSAA committees, Legislative Council or interscholastic activity league committees under CHSAA. Board member Paula Peairs read the Resolution.

Board members thanked Rob for his role in CHSAA, and his work with the District coaches that support CHSAA.

Rob assured the Board he has been working on alternative sites for the District swimmers while Centennial Pool is closed until the end of December. The District swimming season starts November 12, so the closing will impact the swimmers for one month.

# Adoption of Resolution Proclaiming Classified School Employees Week, October 15-19, 2018 (8.3)

Karen Ragland moved that the Board of Education approve a Resolution proclaiming October 8-12, 2018 as "Classified School Employees Week". Paula Peairs seconded.

Damon Brown stated Classified School Employees Week promotes public awareness of the importance of classified employees in the public school system. He honored classified school employees as a valued and integral part of the school system, and emphasized that their work is as vital to the success of students and teachers. He then read the Resolution.

Erie High School Student Advisory Council member Christian Haakmeester asked about the significance of recognizing the classified staff. Damon explained that roughly half the District's 5,000 employees are considered classified, and the District believes it is important to recognize the support the classified staff provide because their work is essential to creating a high quality learning environment in all of our schools and classrooms.

# Approval of Contract for The Wild Plum Center for Young Children and Families (8.4)

Joie Siegrist moved that the Board of Education approve the service agreement between the District and Wild Plum Center for the 2018-1019 school year. The District pays for these slots through the Colorado Preschool Program grant funds that are provided by the State of Colorado. John Ahrens seconded.

Dr. Diane Lauer reported that the District, through its Early Childhood Department and District Advisory Council, enter into this agreement with Wild Plum Center in order to provide preschool services to eligible four-year-old children. The District will pay a monthly tuition rate of \$290 per child placed (not to exceed 58 children). Dr. Lauer answered questions from the Board members regarding the importance of the liaison with Wild Plum Center.

# <u>First Reading, Discussion, New Board Policy FFA – Dedications, Memorials, and Recognition (8.5)</u>

Karen Ragland moved that the Board of Education adopt new Board policy FFA – Dedications, Memorials and Recognition without a second or third reading. Paula Peairs seconded.

Brian Lamer reported that this new Board policy is proposed to create consistent guidelines for future inquiries about establishing memorials. This policy prohibits physical or living memorials on District property.

# <u>Approval of Change Order 1 to Construction Manager/General Contractor Contract</u> for Niwot High School Renovation Project (8.6)

Karen Ragland moved that the Board of Education approve Change Order 1 for the amount of \$196,560 to the Construction Manager/General Contractor (CMGC) contract with JHL Constructors, Inc., for the Niwot High School Renovation project for a total contract value of \$2,600,680. Further, that the Board authorize Brian Lamer, Assistant Superintendent of Operations, to sign contract documents and change orders up to the above referenced amount, in accordance with Board of Education policy. John Ahrens seconded.

Brian Lamer reported that, on May 23, 2018, the Board approved the Construction Manager/General Contractor (CMGC) with JHL Constructors, Inc., for the Niwot High School Renovation project for \$2,600,680. This change order amount is already included in the approved total contract value.

Change Order 1 includes the cost associated with moving the modular classrooms, owner requested changes, and unforeseen field conditions uncovered during Phase 1 of construction. Change Order 1 is funded under the 2016 Bond program.
