Paula Peairs moved that the Board of Education approve the purchase of Network Switches, Access Points, Controller Licenses and Phones for a net bid amount of \$1,448,053.53 to Venture Technologies. Chico Garcia seconded.

Greg Fieth reported that this purchase will replace end-of-life network switches at 38 sites as part of a planned refresh cycle along with network switches, access points, controller licenses and phones for the new APEX school site. The funding for this is from bond and mill levy dollars dedicated to technology.

The Purchasing Department issued Bid No. 2019-044 on December 20, 2018. Three (3) responses were received by January 24, 2019. All responses were reviewed for minimum qualifications, equivalency of products, and compatibility with the existing network. Award is recommended to the lowest qualified, responsive and responsible bidder Venture Technologies.
